### Reading

#### Attainment (all key stages) Guidance

- Key stage 1 attainment of the expected standard in reading (90%) was significantly **above** national and in the **highest** 20% of all schools in 2019, as well as in 2018. Key stage 1 attainment of greater depth in reading (38%) was significantly **above** national and in the **highest** 20% of all schools in 2019, as well as in 2018 and 2017.
- There is nothing significant or exceptional to highlight for pupils meeting the phonics expected standard (32+) in Year 1 in 2019, therefore no conclusions can be drawn from this data. There were 7 pupil(s) that were screened in Year 2 in 2019; 5 of those met the expected standard.
- There is nothing significant or exceptional to highlight for the early years foundation stage attainment of the expected standard reading early learning goal in 2019, therefore no conclusions can be drawn from this data.

## Writing

#### Attainment (all key stages) Guidance

Key stage 1 attainment of the expected standard in writing (80%) and greater depth in writing (24%) was significantly above national and in the highest 20% of all schools in 2019.

#### **Mathematics**

#### Attainment (all key stages) Guidance

- There is nothing significant or exceptional to highlight for key stage 1 attainment of the expected standard and greater depth in mathematics in 2019, therefore no conclusions can be drawn from this data.
- There is nothing significant or exceptional to highlight for the early years foundation stage attainment of the expected standard mathematics early learning goals in 2019, therefore no conclusions can be drawn from this data.

## Absence (whole school)

#### Autumn 2020 absence Guidance

This data relates to absences during the coronavirus (COVID-19) pandemic and should not be compared directly to previous years. There were 889 sessions missed by pupils not attending in circumstances related to coronavirus (COVID-19) – these did not count as absence within the data.

- Overall absence in autumn 2020 (2.3%) was in the **lowest** 20% of all schools.
- There is nothing significant or exceptional to highlight for persistent absence in autumn 2020, therefore no conclusions can be drawn from this data.
- There is nothing significant or exceptional to highlight for overall absence and persistent absence compared to schools with a similar level of deprivation in autumn 2020, therefore no conclusions can be drawn from this data.

#### Absence for 2018/19 and earlier Guidance

- Overall absence (3.0%) was in the **lowest** 20% of all schools in 2018/19.
- Persistent absence (2.9%) was in the **lowest** 20% of all schools in 2018/19.
- There is nothing significant or exceptional to highlight for overall absence and persistent absence compared to schools with a similar level of deprivation in 2018/19, therefore no conclusions can be drawn from this data.

## Exclusions (whole school) Guidance

- There is nothing significant or exceptional to highlight for total fixed period exclusions in 2018/19, therefore no conclusions can be drawn from this data.
- There is nothing significant or exceptional to highlight for repeat fixed period exclusions in 2018/19, therefore no conclusions can be drawn from this data.
- The 1 pupil with at least one fixed period exclusion in 2018/19 was excluded on more than one occasion but fewer than 10.

- Of the 2 fixed period exclusions in 2018/19, both were for **persistent disruptive behaviour**.
- There were no permanent exclusions in 2018/19. The national average for this year was close to zero. There were no permanent exclusions in the previous two years either.

#### MAT/LA level information Guidance

As at December 2020:

- this school is maintained by Central Bedfordshire local authority which maintains 59 primary schools, 4 secondary schools, 2 special schools, no pupil referral units and 2 nursery schools.

#### School workforce Guidance

According to the November 2019 school workforce census:

- in 2018/19, 33.3% of teachers had at least one period of sickness absence compared with a national average of 54%.
- in 2018/19, 2.2 days on average were lost to teacher sickness absence compared with a national average of 4.1.
- at the time of the census, there were no full-time vacant teacher posts in the school.

#### Local area Guidance

- The school location deprivation indicator was in quintile 1 (least deprived) of all schools.

#### Finance Guidance

- In 2018/19, the school had a revenue reserve of £187,095.
- In 2018/19, this school had a positive in-year balance (£543), the second year in a row in which income has exceeded expenditure.
- In 2018/19, this school had a per pupil spend of £4,356, an increase of £159 per pupil from the previous year.
- In 2018/19, this school received £1,518,294 in grant funding, £224,843 more than the national average.
